ADMISSION REQUIREMENTS:

ACT score of 24 or above

or

Cumulative University GPA of 3.2 or higher

The primary goal of the Center of Excellence in Computer Information Systems is to prepare graduates who can take the lead in the development and application of information technology tools in business, industry, government, and education. The Center of Excellence provides an opportunity for students who demonstrate superior academic performance, exhibit leadership potential, and have a desire to participate in Center events to become members by adding the academic minor. Students from any program of study may be admitted if they meet the admission standards.
